NSCL Amendment 1

Proposed Change:

CONSTITUTION Article IV Amendment

Section 1. Origin of Amendments. Any member of this organization may propose an amendment to this Constitution by submitting such to the NSCL President, the NSCL Parliamentarian, and the National Committee. Furtherance of a proposed amendment requires approval by the ACL in a manner in accordance with the Constitution and Bylaws of the ACL.

Section 2. Amendment Procedure. A proposed amendment to this Constitution shall be considered at the first annual meeting held following final approval by the ACL. The procedure shall be as follows:

2.1. The NSCL Parliamentarian shall give notice of the proposed amendment no later than the first assembly of the annual meeting at which the amendment is to be considered.

2.2. The NSCL Executive Board shall report to the membership the possible effect of the amendment and may recommend whether the proposed amendment ought to be ratified.

2.3. The membership shall debate the proposed amendment at the antepenultimate assembly of the annual meeting.

2.4. Voting shall take place during the penultimate assembly of the annual meeting, unless postponed by the Executive Board or the membership.

2.5. A ~~three-fourths~~ two-thirds vote of the members present and voting shall be required for passage of a proposed amendment.

2.2. The NSCL Executive Board shall report to the membership the possible effect of the amendment and may recommend whether the proposed amendment ought to be ratified.

2.3. The membership shall debate the proposed amendment at the antepenultimate assembly of the annual meeting.

2.4. Voting shall take place during the penultimate assembly of the annual meeting, unless postponed by the Executive Board or the membership.

2.5. A three-fourths vote of the members present and voting shall be required for passage of a proposed amendment.

Rationale:

This change would streamline the amendment procedures for the Constitution and Bylaws and eliminate any confusion since the two articles appear nearly identical. In addition, the requirement is the same as the ACL requirement for amendments.

Rationale:

This would reflect the necessary constitutional changes should NSCL Amendment 1 pass.

NSCL Amendment 3

Proposed Amendment: Duties of the President

8.1.7. Have jurisdiction over the talent show and reception at the National Junior Classical League Convention;

Previous Section:

8.1.7. Have jurisdiction over the reception at the National Junior Classical League Convention;

Rationale:

Throughout convention the Vice President has Ludi events that conflict with the talent show. Currently, the Vice President is expected to support and check in with the progress of the talent show after midnight. At the same time, the Vice President must prepare for the ludi events that will happen the next day and wake up early. On the other hand, the President, outside of running General Assemblies and hosting the banquet, has minimal responsibility at convention. Therefore, the President, would be a better fit for presiding over the talent show.

NSCL Amendment 4

Previous Section:

Rationale:

NSCL Amendment 7

Proposed Amendment: Duties of the Treasurer

8.4.7. Create a financial report in each newsletter available to any member upon request; and.

Previous Section:

8.4.7. Publish a financial report in each newsletter; and,

Rationale:

A financial report has not been published in each newsletter for some time. Members should be able to view this information upon request. Altering this amendment would reflect how the organization currently runs.

Proposed Amendment: Duties of the Parliamentarian

8.5.2. Maintain a list of the names of all members attending each assembly in order to create a list of eligible voters.

Previous Section:

This would be a new assertion that would cause a number shift in the list of duties.

Rationale:

Since the Parliamentarian is responsible for voting procedures and making sure each vote is cast by an eligible person to create a list of eligible voters the Parliamentarian should be directly aware of who is showing up when. The bylaws should explicitly state this duty under Parliamentarian so attendance is not assumed by the Secretary in the future.
